#### **Fund Profile**

The primary objective of the Credicorp Capital Latin American Corporate Debt is to achieve high levels of income and secondly, capital appreciation by investing in a diversified portfolio of fixed and floating rate securities of varying maturities from government institutions and companies incorporated or having their principal business activities in the Latin American region (herein "LatAm Issuers"). The Latin American region includes, but is not limited to Mexico, Brazil, Colombia, Chile and Peru. The fund may invest in the islands of the Caribbean on an ancillary basis. In addition, the fund may invest its assets in financial derivatives for hedging purposes only.

The fund will seek to hold a minimum of 70% of its assets in Latin American corporate debt instruments of LatAm Issuers, notably in high yield debt instruments.






### **Top Holdings (Overweight / Underweight) vs Benchmark**




### **Breakdown of Holdings by Credit Rating**
